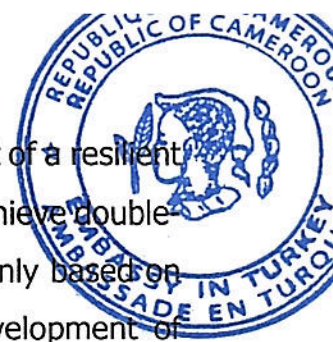

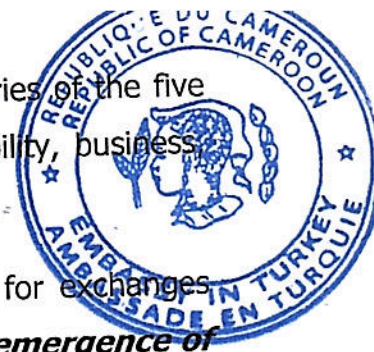

## 9. THE YAOUNDE FORUM

- Sharing lessons, achievements, experiences and discussing strategies, initiatives and good practices on industrialization in the African Continent,
